Terms of Service

By sending any photographic equipment to *Sell My Cameras* the consignor agrees that they have read these *Terms of Service* completely and agree to all following terms and conditions.

Postage

Sell My Cameras will send a prepaid postage label to ship the items with. This allows the package to be tracked to assure that it arrives safely. All packages sent to *Sell My Cameras* will be insured for slightly more than the estimated value of the equipment. Please pack the items very carefully. Shipping insurance will not cover damaged items that are not well packed. When an item sells it will be insured for the full value of its sale price during mailing. *Sell My Cameras* shall not be held liable for any damage that occurs during shipping, but will help to file any necessary insurance claims. Please note that to file an insurance claim for a broken item it may be necessary to prove that the item was working prior to shipping and packed well.

Fees and Payment

Sell My Cameras will sell the equipment listed on the Consignment Agreement for the consignor and will pay the consignor a percentage of the total profit from the sale of the items. The total profit will be calculated by subtracting all eBay fees (which can be viewed at ebay.com) and postage fees associated from the sale of the equipment from the total cost paid by the buyer (including shipping.) The consignor will be paid using a tiered percentage system. The consignor will receive 60% of the first \$100 of total profits, 70% of total profits from \$101-\$500, 75% of total profits from \$500-\$1000, and 80% of the remainder of total profits over \$1000. *Sell My Cameras* will send the consignor a detailed summary of how the total was calculated along with payment by check or PayPal as soon as the final buyer has received the item and is satisfied with it per our 3-day return policy. *Sell My Cameras* may not be held liable in excess of the amount owed for lost or misdirected payment. The consignor is responsible for any charges associated with lost or misdirected checks.

Starting Prices and Reserves

eBay charges listing fees based on the item's starting price and reserve price as well as final selling price. The reserve is the lowest price that the consignor is willing to sell the equipment for. The reserve represents the lowest price the item will sell for on eBay, before any eBay or consignment fees, and not the lowest amount that the consignor will receive. The consignor may request a reserve or lowest price for each item listed. If the item does not sell for the reserve price, *Sell My Cameras* can offer it to the highest bidder at the consignor's discretion. The price can be lowered or the item may be offered for sale in a fixed priced store listing at the option of the consignor. The consignor will be responsible for any fees associated with the listing if the equipment does not sell. These fees will be subtracted from the total profit after the item sells, or the item(s) can be returned to the consignor once any outstanding fees and shipping costs are paid by the consignor. The reserve price is at the discretion of *Sell My Cameras*. The price will be lowered 10% for every 14 days (2 7 day auction cycles) that the item does not sell. *Sell My Cameras* will notify the consignor by email of any changes in reserve or starting prices. The consignor is not required to provide a reserve price. *Sell My Cameras* will do everything possible to ensure a fair sales price with minimal eBay fees.

Fraud / Criminal Activity

All packages sent to *Sell My Cameras* will be overseen by an independent witness (most likely the FedEx clerk.) Any attempts at fraud (by sending an empty box, or otherwise) will be reported to the proper authorities and prosecuted to the fullest extent of the law. The consignor accepts full responsibility for the sale of stolen goods. If equipment sent to *Sell My Cameras* is found to be stolen, it will be handed over to the proper authorities along with the consignor's information and no payment shall be made to the consignor.

Liability

Sell My Cameras shall not be held liable for loss or damage of equipment sent for consignment due to fire, theft, flood, or any other causality or act of god. Although all due care will be taken with equipment sent for consignment, *Sell My Cameras* shall not be held liable for any damage to items sent for consignment. If any equipment is found to be seriously damaged, the consignor may elect to sell the item at a lower price for "parts or repair" or it may be returned to the consignor at their expense. In the unlikely event of loss of the consignor's equipment the maximum liability of *Sell My Cameras* shall be limited to 50% of the equipment's estimated value. The estimated value is based on recent eBay sales, and the actual sale price of equipment sold may be higher or lower.
